Tables: Height is 29.25" from floor to table top

Round – 60" diameter (seats 6-8)

Rectangle – 72" long x 30" wide (seats 6)

Cocktail – 30" diameter can be set either 30" or 42" high

Chairs: Folding 15.5" high from Chair seat to floor; 34" from top of chair backrest to floor

Seat 17.5" square; back 19.5" wide by 15.5" high (seat to top of chair) rectangle

Advanced Booking:

Non-Residents can book a maximum of **10 months** in advance. Bookings for a full 10 months in advance can be booked on the 1st of the month, 10 months prior – see example below

Ex: Want to book your wedding for August 12, 2018? Your booking would be accepted as of Oct. 1, 2017

| Damage Deposit Cheque | Due within one week of Rental Agreement being written |
| Proof of insurance | Due within one week of Rental Agreement being written |
| Third Party Vendor/contractors Insurance Certificate | Due one month prior to event |
| Party Alcohol Liability Insurance (PAL) | Due 10 days prior to event |
| Liquor License | Due on day of event |

SOCAN and Re:Sound fees are tariffs that we are required to charge rentals who will be using live or recorded music as part of the entertainment for an event. SOCAN and Re:Sound use the revenue from these two tariffs to support performers, song writers and music copyrighters involved in the music industry.

| 75% refund | Rental cancelled more than three months prior to the rental date |
